The VP also writes quarterly reports to investors along with the president and helps keep track of our portfolio's NAV valuation.

A successful applicant must have a strong foundation in investing and experience in conducting research, valuation models, and leading a team. Though applicants are encouraged to have gone through the Analyst Candidate Program and Research Team, this is not required. The VP position is one of the stronger paths for students into the buy-side. The position gives a strong understanding of investment research, as well as unparalleled experience leading a team and managing a portfolio of real capital for investors.
